## **NEW COWBOY SHOOTER CLINIC** (Chuck Crooks)

The first 2008 New Cowboy Shooter Clinic, at our IWLA-WAC Chapter, will be Saturday, March 8, 2008.

[Applications are now available on the IWLA-WAC and Our Damascus Wildlife Rangers web sites.](#) Class sizes are limited, and seats are on a first come, first serve basis.

The purpose of the clinics is to introduce the sport to potential enthusiasts who'd like to give it a try without "the whole world watching." Though playing the game under the watchful eye of the Range Officer and their timer is part of the fun, it can be a little intimidating if you're new. SAFETY and fun are the real focus of the sport, and we'd like to be sure everyone gets off to the right start. Students will learn how the game is played, hear the SASS rules, see the equipment and accessories that are required, and get a chance to try out the range of firearms that are appropriate to the sport. A history of the sport is included in the classroom portion. You can look at the [Clinic Outline](#) (also on the web sites) to see what's covered.

Atlantic Guns and our own Damascus Wildlife Rangers provide all equipment and ammo, if students do not have their own yet. Each person will get the chance to shoot a real cowboy scenario or two using the ol' hoglegs, scatter gun and lever action rifle! You will feel the fear of that dang buzzer and learn what real brain fade is like!

## **DUES INCREASE FOR 2008** (Joe Gick)

For any members joining after January 1, 2008, there will be an increase of \$20 in the yearly dues (to \$130 per year) and an increase in the one time initiation fee of \$20 when joining. These costs will not affect current members until you renew for 2009. We have kept the costs the same for many years, and kept dipping into our reserve fund to do so. Increasing insurance, energy, and supply costs make this impossible. Our dues only cover about one third of what it costs to run the chapter. We REALLY need your participation at our BBQ's and similar events to bring in additional revenue and to offset future increases.

To help put things in perspective, if you go to Starbucks just one time each week for a year and buy a Grande Latte, it will cost you over \$221.00. That is 70% more than what it costs to be a member of our club - a real deal!

Many urban and suburban residents are installing rain barrels to capture roof top runoff to reduce stormwater impacts to our local streams as well as for later watering use. #### **Montgomery County Environmental News**

For Montgomery County residents, the Montgomery County Department of Environmental Protection (DEP) will be sponsoring a series of 'Make and Take' rain barrel workshops this spring at Brookside Gardens in Wheaton. The DEP will also soon begin a program for County residents and businesses that will provide a rebate to those who purchase and install qualifying runoff control practices (like rain barrels, rain gardens, and converting lawn areas to conservation landscaping, and planting native trees). There will be a maximum rebate amount per practice type and lot, and all applicants must sign a letter agreement to allow inspection for a set period after installation. Conditions and applications will be posted at [Rainscapes.org](http://Rainscapes.org) by mid-January 2008. The pot of money is limited, so those who apply earliest are most likely to get a rebate. ### **DUES ARE NOW PAST DUE**

Your IWLA membership expired on 12/31/2007. If you have not renewed, a second notice was sent out on January 6, 2008. If payment is not received by January 31, 2008, there will be a \$40 late fee to renew your membership. If you do not pay this, you must wait to rejoin in 2009 or later, and the initiation fee will be \$60 by then.

Your 2007 Range Access Card will be honored until 01/31/2007. As of February 1, you will not be able to use any range without a 2008 card. We will be checking cards and be very vigilant about this. As I have said in the past, it can take several weeks after I get your payment to get a card back to you. That is the way the system works, and I have no control over it.

It is very expensive to do a second mailing, but the 300 members who haven't paid yet have made this necessary. Get your payment in now and avoid losing range privileges or paying a late fee. It is totally up to you.

**SHOOTING HOURS:** Permitted rifle and pistol range shooting hours are posted on the box, which contains the range sign-in register, as well as above the range entry card reader. For January 2008, starting time is 10:00 AM daily and ending time is 5:00 PM, unless some activity has preempted the range (see "Upcoming Events Affecting Range Availability" below).

My thanks to Josh Jonas, Alan Pressman, Al Goldschmidts, Aleks Goldschmidts, and Charles McIntosh for their help with range cleanup on our December Maintenance Day.

Also, again, thanks to Al Goldschmidts for another supply of pistol target backers and to an anonymous donor for several full sheets of plywood.

### **REMINDERS**

**Rapid-Fire:** Sure, we know that it's fun to shoot a firearm as fast as you can pull the trigger. However, please remember that, even when you are alone on the range, we have neighbors and they are definitely sensitive to sound coming from our ranges, especially "rapid fire." We have

been working hard to develop a good working relationship with our neighbors, following a formal noise complaint to the county some years ago. Although sound measurements show we are within legal limits, the county government takes any complaints very seriously and keeping the ranges open can become both difficult and expensive. Since rapid fire shooting remains controversial and we don't have a rule forbidding it on the rifle and pistol ranges, we depend upon our members to be sensitive to this issue. If each shot you fire is truly aimed, you are probably firing at a reasonable speed. If you are still firing as fast as you can pull the trigger, maybe the target is too close. If someone asks you to slow down, please do so without an argument. Slower shooting is better than no shooting at all.

**Range Road Closures:** Winter arrived officially between December 21 and December 22, and with it comes the likelihood of snow and ice accumulation on the rifle/pistol range road. If the road becomes impassable or overly soft due to heavy precipitation, we may close it even though the ranges remain open for use. In such cases, we will post a sign explaining the closure at the range sign-in register, and we will lock the gate in the closed position. Please watch for and comply with such notices. If the sign indicates that the road is closed but the ranges are open, you may walk to the ranges. However, even if you have an off-the-road vehicle that might make it through snow-covered fields, **DO NOT ATTEMPT TO DRIVE TO THE RIFLE AND PISTOL RANGES WHEN THE RANGE ROAD IS CLOSED!**

**Rifle and Pistol Range Rules:** The rules governing Rifle and Pistol Range safety, conduct, permissible firearms, and violation policy are posted at the covered pistol range, the covered rifle range, the notice board between the pistol ranges, the notice board at the path leading to the covered rifle range, on the chapter WEB site ([damascusiwla.org](http://damascusiwla.org)) and in MS Word format from me via email, when requested. Sometimes questions come up. Though our bylaws indicate that you can call any Board of Directors member about these rules, you will be better served to start with the folks closest to them, i.e., range orientation instructors or the committee chairman.
