This year March has two full moons. The first – Full Worm Moon occurred on March 1st. Native Americans – using the lunar phases to identify the cycle of the seasons - coined the name. During the time of the Full Worm Moon, the ground begins to soften and the Earthworm is able to tunnel to the surface encouraging the return of migrating birds and the Red Robin. Roots also make their way through the soften ground – the surface becomes alive with greenery and budding flowers. A sure sign spring is coming! March 20th is the first day of spring.

A second full moon in a month is referred to as a Blue Moon. The Blue Moon occurs March 31st. The phrase “Once in a Blue Month” usually means a rare occurrence – but in reality a Blue Moon occurs approximately every 30 months.

Now that clocks are moved forward and with spring right around the corner – the WAC ranges will become busier as the weather warms. For conservation enthusiasts – projects such as tree and garden maintenance and the Watershed Clean-Up are on the calendar. Check out the WAC calendar – for scheduled events and range availability.

Because the ranges and grounds will be busier – the need for members to roll-up their sleeves and extend a helping hand with ground and range maintenance day is even more important. The next maintenance day is scheduled for Sunday March 25th. Just a Reminder – all ranges are closed until noon on the 25th.

MEMBERSHIP E-MAIL

Communicating to all of the members is a daunting task. Our primary sources of communication are via E-mail, the newsletter and the web site.

We use E-mail for membership renewals, reminders, special events, upcoming projects, closings and anything deemed important for the membership. We try to keep these to a minimum and we never give the list to anyone else.

On the membership application is a space for your E-mail address. This, along with your other information, is entered into the chapters main membership data base, which is maintained by the membership secretary.

A copy of the E-mail addresses are sent to Chuck Crooks, the web master, for inclusion on our distribution list for the chapters bulk E-mailings.

Over the years, the two lists have drifted apart partially because of changes, which in the case of E-mail addresses, happens often. Folks do change E-mail addresses often and if we did get the change from one source or other, it was not always passed on to the other.

In mid February, I took all E-mail addresses from both data bases and purified them to establish a good list for sending club E-mails. This took over 18 hours and generated some serious eye strain!

Anyone, that had an E-mail address in the main data base, that was not on the bulk mailing list, was then added to that list. Each person that was added was also sent an E-mail explaining the addition.

This was a complicated process, as many members have two or more addresses, including a home address and a work address. Some addresses were old or invalid and these were deleted.

The new bottom line is when you change your E-mail address, we need to know. Please send any E-mail address changes to Chuck Crooks IzaakWaltonWAC@aol.com. Include your name, your old address and your new address. I will then forward your change to the membership secretary. Whenever we add an address to the distribution list, you will get a confirmation E-mail.

As a reminder, many company E-mail servers, especially a work or government one, will block E-mails that are sent in bulk lists like ours. When I send a chapter E-mail, it goes to over 1,600 addresses at once. So if it is important for you to keep up, please provide an address other than a corporate or government address if possible. It is equally important for you to keep your address current because membership renewals are sent via E-mail.

All chapter E-mails are sent from izaakwaltonwac@iwlwac.org. The subject line will always be in all caps and the description line will start as "IWLA-WAC". If possible, add izaakwaltonwac@iwlwac.org to your approved list.

At the very least, we send an e-mail, usually around the middle of the month, letting members know that the current edition of the Wildlife Gazette, the clubs newsletter, is available on our website.
