A LITTLE BIT ABOUT CHRISTMAS TREES

Did you know?

The moisture in a fresh tree weighs more than the tree does when dry.

Christmas tree farms cover about one million acres in the United States. Those trees provide enough oxygen to supply the daily needs of eighteen million people. Plant a tree.

When you first put your tree in the stand, be sure to cut a small amount off the bottom (enough to give a fresh surface) and first fill the stand with water at about 180 degrees. Warm water will keep the tree base "open" longer so it will take up water better.

COMMITTEE REPORTS

CONSERVATION COMMITTEE (Meo Curtis)

Fall Adopt-A-Road and Watershed Clean Up

The Chapter completed our Fall adopt-a-road/watershed clean up on Saturday October 18, 2008. There were about 20 volunteers, including a high school student who earned student service learning credits for his participation.

We picked up trash from our designated road (Mullinix Mill Rd. from Rte. 108 to the Patuxent River) and three other segments: Long Corner Road from Rte.

108 to Mullinix Mill Rd., Gue Rd from where it joins Howard Chapel Rd. to Long Corner Rd., and Annapolis Rock Rd. from the Patuxent River to Rte. 108.

Special thanks to Jim Piatetski and Judy Reilly who drove their own cars around to keep us organized.

We picked up about 30 bags of trash, 7 5-gallon plastic pails (full of something that remained a mystery because we were not about to take the lids off), 3 tires, and miscellaneous car parts. Once again, there were many beverage containers and fast food trash items. Since each bag of trash weighs approximately 20 pounds, there were about 600 pounds of trash sent to the transfer station along with the other 'junk'.

Your time in volunteering to help out your community through the Adopt-A-Road/Fall Clean Up is worth a lot of money! According to the Bureau of Statistics, the estimated dollar value of volunteer time in 2007 was \$17.42 per hour (SOURCE:

http://www.independentsector.org/programs/research/volunteer_time.html.) The value of volunteer time is based on the average hourly earnings of all production and nonsupervisory workers on private nonfarm payrolls as determined by the Bureau of Labor Statistics with 12% added for estimated benefits. These figures can be used for 'in-kind' services required for certain grants.

Next clean up will be in April, in conjunction with the Patuxent and Potomac Watershed Spring Clean Ups.

Montgomery County's Federal Clean Water Act Stormwater Permit

And after learning about opportunities to improve County streams, you might want to check out the third-round Montgomery County Stormwater Permit. The Maryland Department of Environment (MDE) has issued its formal "tentative determination" for Montgomery County's Municipal Separate Storm Sewer System

(MS4) permit, which is required by the federal Clean Water Act. The draft five-year permit requires actions to eliminate the negative impacts of polluted stormwater runoff in Montgomery County and will be the template followed for all other Maryland jurisdictions to control pollutants entering local waterways and to restore the Chesapeake Bay. The exact requirements may differ based on locality population.

There are major new requirements in the Montgomery County MS4 permit which include the restoration of an additional 20 percent of the County's impervious surfaces (on top of 10 percent previously restored, for a total of 30 percent restored by 2013); the development and implementation of strategies to achieve a trash-free Anacostia River as part of the County's commitment to the goal of a trash-free Potomac River by 2013; and the establishment of pollution limits, also known as Total Maximum Daily Loads (TMDL), necessary to meet water quality standards for federally listed impaired waters. The Montgomery County Department of Environmental Protection has estimated that it may cost as much as \$200 million over the next six years to meet these watershed restoration and protection goals.

A public hearing will be held on the tentative determination on Wednesday, November 19, 2008 at 7:00 P.M. in the County Council Office Building Auditorium, 100 Maryland Avenue, Rockville, Maryland 20850. Persons who wish to present information regarding the tentative determination may speak at the public hearing, submit written comments at the public hearing, or submit a written statement to MDE no later than November 24, 2008.

RIFLE AND PISTOL COMMITTEE

INFORMATION: For more information about any rifle or pistol range activities mentioned in this article or suggestions for topics for this article contact Tony Evans, by email at tony.evans@verizon.net or telephone 301-706-9121.

SHOOTING HOURS: Permitted rifle and pistol range shooting hours are posted on the box, which contains the range sign-in register, as well as above the range entry card reader. For November 2008, starting time is 10:00AM daily and ending time is 4:30PM, unless some activity has preempted the range (see “UPCOMING EVENTS AFFECTING RANGE AVAILABILITY” below).

REMINDERS

Rifle Range Target Placement is permitted at the 50, 75, & 100-yard berms. This is perfect for all center-fire and some rim-fire rifles. If you want to shoot at 25-yard targets with rim-fire ammo then use the covered pistol range, where all currently available rim-fire caliber rifles may be used.

Rifle and Pistol Range Rules: The rules governing Rifle and Pistol Range safety, conduct, permissible firearms, and violation policy are posted at the covered pistol range, the covered rifle range, the notice board between the pistol ranges, the notice board at the path leading to the covered rifle range, on the chapter WEB site (damascusiwla.org) and in MS Word format from Tony Evans, via email, when requested. Sometimes questions come up. Though our bylaws indicate that you can call any Board of Directors member about these rules, you will be better served to start with the folks closest to them, i.e., range orientation instructors or the committee chair.
